#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Millath Teachers Education College, Sooranad P.O. Kunnathur, Kollam 690522, Kerala has by affidavit consented to come under New Regulations and sought for one basic unit in B.Ed.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- 4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely.

Vide paper read as (2), the Syndicate at its meeting held on 30.05.2003 decided to recommend NOC to the proposed B.Ed. Training College to be established by the Chairman, Millath Educational Trust. Vadakkevila P.O., Kollam for the academic year 2003—2004.

Vide paper read as (3), the Government of Kerala has accorded sanction to the Unaided B.Ed. Training College by the Chairman. Millath Educational Trust. Vadakkevila P.O. Kollam from the academic year 2004—2005 subject to recognition by the NCTE, affiliation by the University concerned and subject to the decision of the Hon ble High Court of Kerala in WA 379/04 and 474/04 and connected cases.

Vide paper read as (4), the National Council for Teacher Education granted recognition to the Millath College of Teacher Education, Sooranad P.O., Kunnathur, Kollam for the secondary course of one year duration from the academic session 2004—2005 with an annual intake of 100 students.

Vide paper read as (5), the Government of Kerala has accorded sanction for starting the B.Ed. Degree Course in the Millath College of Teacher Education, Sooranad P.O., Kunnathur, Kollam from the year 2004—2005 in accordance with the relevant Rules and Regulations of the University concerned, subject to formal decision of the Honble High Court in Writ Appeals.

Vide paper read as (6), the Syndicate at its meeting held on 12.05!2005 decided that provisional affiliation be granted to the Millath College of Teacher Education. Sooranad P.G., kunnathur, Kollam for the academic year 2004—2005 with permission to commence B.Ed. Degree classes for the academic year 2005—2006 with an annual

intake of 100 students and a minimum of 10 candidates in each subject for the B.Ed. Degree Course in the following optional subjects:

(1) English. (2) Commerce, (3) Physical Science. (4) Social Science. (5) Natural Science.

Millath Educational Trust, Vadakkevila P.O., Kollam and recommended to grant sanction to the following additional optional subject for the B.Ed. Degree Course: Mathematics.

Vide paper read as (10) and (11), the Chairman, Millath Educational Trust, Vadakkevila P.O., Kollam has fulfilled the prescribed formalities for obtaining provisional affiliation for the Training College by executing the Agreement and Letter of Undertaking.

Sanction has, therefore, been accorded to the Millath College of Teacher Education, Sooranad P.O., Kunnathur, Kollam being granted Provisional Affiliation for the academic year 2004—2005 with permission to commence the B.Ed. Degree course in the academic year 2005—2006. The total strength of admission shall be 100 and the minimum number of candidates in each subject shall be ten (10). The following are the optional subjects sanctioned:
